Prize terms and conditions

The Prize: A seven-night (7) all-inclusive holiday for two (2) adults at any Sandals Resort in the Caribbean in one (1) Luxury level room with a king size bed (subject to availability and selected blackout dates).

The resort accommodations are inclusive of all meals, unlimited premium brand beverages, daily & nightly entertainment, an array of land and water sports activities, including scuba diving (for certified divers), snorkelling, Wi-Fi in all rooms and public areas, resort gratuities, resort taxes and resort transfers to and from the selected or designated resort's airport.

The Prize excludes: Any flights, domestic transfers, including any internal flights or transportation to London, spending money, telephone calls, Red Lane Spa treatments and services, specialty dining, tours & excursions, inter-island transportation, SCUBA certification courses, island departure taxes and purchases made at the Sandals Resorts Specialty Shops.
